Completed-May 2017	A specific project was selected as pilot by Fundecooperación in order to implement an analysis on the gender impacts, a project that not only includes different sectors but also communities (such as indigenous people and farmers). This assessment allowed us to reconfirm the general gender issues that are present in the different projects that we are financing and in general, in the country; issues that we expect to manage in a better way by the creation of guidelines.

On-going	The Executing Entities were prepared on different topics: such as gender equity and humans rights. Different workshops were conducted in order to create knowledge on gender equity and previous legal basis on the matter. However, different analysis on gender were made by different other projects that we consider are important to take into account in order to undertake possible procedures. An improvement of the Environmental and Social Policy was made including different aspects on gender equity and possible actions at the local level. Also, an improvement on the Ethics Code was made in Fundecooperación to strengthen the Gender approach.
