Proposed Decision

Dear CTF Trust Fund Committee members,

As you will recall, the Committee approved the CIF ACT Women-Led Coal Transitions (WOLCOT) Mechanism in September 2022.

The First Call for proposals for “preparatory” grants – up to 150K under WOLCOT was issued in December 2022, with focus on South Africa and Indonesia. These grants are intended to support analytical, consultation and capacity building activities toward creation of women led coalitions, which could be later scaled up under the projects to be developed under ACT Investment Plan.

Six proposals from four MDBs were received by early February. In March -May, the CIF Administrative Unit supported MDB teams to further revise the proposals to ensure alignment and complementarity between activities of different MDBs, as well as other development partners. The proposals were also reviewed by the Advisory Group (AG), set up under WOLCOT , and the comments provided by the AG members have been addressed in the final versions.

Please find attached for your review and approval the 6 grant proposals for a total of USD 900,000, as detailed below:

1. South Africa - IFC: MDB Gender Deep Dive/Diagnostic: Private Sector Module - USD 150,000
2. South Africa - AfDB: JOBS FIRST: Gender and Social Inclusion in the Mpumalanga Province- USD 150,000
3. South Africa - WB: Catalyzing Change for Women and Excluded Groups in South Africa's Path to a Just Transition - USD 150,000
4. Indonesia – ADB: Preparatory qualitative study for informing the formulation of the WOLCOT Proposal - USD 150,000
5. Indonesia – WB: Women for Just Transition Coalition - USD 150,000
6. Regional (South East Asia) - ADB: Regional cross-learning dialogues and consultations- addressing gender inequalities in energy transitions - USD 150,000
