### Proposed Decision

Dear CTF and SCF Trust Fund Committee members,

Kindly recall that, at the Joint [Meeting](#) in January 2022, the SCF and CTF Trust Fund Committees [approved](#) dedicated resources under the FY22 Business Plan and Budget for the CIF Administrative Unit to convene a secretariat for the Just Energy Transition Partnership (JETP) in South Africa with the goal of finalizing the JETP Investment Plan by the end of 2022. This was following a request that the CIF AU perform a technical coordination role, to help facilitate support from the international partners group and key stakeholders, including multilateral and bilateral development finance institutions and the private sector for ambitious coal transition reforms and investments based on a multi-year framework.

In October 2022, the CTF Trust Fund Committee [welcomed](#) the update on the JETP and recognized the role of the CIF Administrative Unit in convening the JETP Secretariat and delivering the JETP IP, which was ultimately endorsed by the Government of South Africa in October 2022. The Committee further noted the interest expressed by some members of the Committees to use remaining funds to continue to support the JETP process during its implementation phase, and requested the Government of South Africa to submit a proposal for the use of remaining funds to support the JETP, including scope of work, roles and responsibilities and timelines for delivery for the CTF Trust Fund Committee's consideration.

It was also agreed that subject to the approval of the CTF Trust Fund Committee, the CTF and SCF Trust Fund Committees would be asked to jointly approve the proposal for the use of remaining funds for the JETP.

The Government of South Africa has now submitted its request along with scope of work for the Committees' consideration. Please note that the CTF Trust Fund Committee approved this proposed use of remaining funds for JETP on June 7, 2023.

The CTF and SCF Trust Fund Committees are requested to approve the following decision:

**The CTF and SCF Trust Fund Committees, having reviewed the request from the Government of South Africa along with the scope of work including key deliverables, approve the**
