We are writing regarding the document entitled, *Revised Mali Renewable Energy Integration (REI) Investment Plan - November 2023*, submitted for your review and approval.

The time period provided for submission of any objections to the decision has now expired. No objections were received. We are, therefore, pleased to inform you that the following decision is now approved:

The GCAP Sub-Committee, having reviewed the document entitled, *Revised Mali Renewable Energy Integration (REI) Investment Plan - November 2023*:

- a. thanked the Government of Mali for the work it has done in preparing the Investment Plan;**
- b. endorsed the Investment Plan for USD 70 million as a basis for the further development of the projects foreseen in the plan;**
- c. taking into account availability of resources and the right-sizing exercise, allocated USD 32.60 million in REI funding to support a modular approach to be determined in accordance with the Investment Plan's indicative pipeline.**

As you will recall, on June 30, 2023, the GCAP Sub-Committee reviewed the document entitled, *Mali Renewable Energy Integration (REI) Investment Plan*, and decided to endorse the Investment Plan *in principle* subject to the submission of a revised Investment Plan by the Government of Mali, that would take into account the comments made by GCAP Sub-Committee members, for the Sub-Committee's further consideration.

At its meeting on November 9, 2023, the GCAP Sub-Committee reviewed the revised REI Investment Plan for Mali and requested it be submitted, with its supporting documents, to the Sub-Committee for review and approval by mail with a deadline of 20 November 2023.
