The **Project Development Objective** is to contribute to national REDD+ efforts to reduce carbon emissions from forests by expanding the national program of Participatory Sustainable Forest Management (PSFM) in Production Forest Areas (PFAs) and developing and piloting Landscape-PSFM in four provinces.

The project will: a) incorporate and monitor forest carbon emission reductions; b) introduce performance payments for forest carbon sequestration; c) focus additional efforts on developing sustainable livelihood options; and, d) foster inter-agency coordination at the landscape scale. It will have the following four components:

- The Village Development Grant will continue to allocate funds for women's livelihood improvement initiatives facilitated by the Lao Women's Union which will facilitate involvement and access for vulnerable ethnic women, widows, and single mothers.
