Implementation Status and Key Decisions

Implementation progress continues to be slow but there have been 2 rounds of sub-project selection in the last 10 months which will yield concrete results. It is also expected that progress will continue to accelerate as the labor intensive, initial preparation for implementation (capacity building, training, consultation) has been mostly completed so the focus can be on implementing the sub-projects.

In terms of concrete results, WWF has reported that the Regional Agrarian Directorates of Loreto, Ucayali and San Martin have issued legal resolutions to recognize 59 communities. These resolutions are in the process of being registered with the Public Registries in each department, which is the last stage in the native community recognition process. This represents 20% of the total target for the recognition subcomponent. The second round of subprojects that was approved in January 2017 included approval for 80 community recognition, 50 land titling and 30 community forestry sub-projects. Next supervision mission is planned for March/April 2017.
